Hardcopy of the Tender document will not be accepting after last date and time as mentioned in the tender schedule (i.e., 29.07.2026 upto 15.00 hrs)

Firms/ Persons interested in the purchase of the above mentioned vehicles must inspect by them on any working day from 22.07.2026to 28.07.2026 between 12.00hrs to 16.00hrs at the Indian Bank, FGM Office, Hazaratganj, Lucknow-226001. Upon inspection the undertaking form (page 7 of the Bid document) will be obtained from bidder for the confirmation of inspection of vehicles, Documents, etc.,

Vehicles will not be sold less than the Reserve Price as mentioned in this tender document.

The bidders are advised to quote individually (i.e. separate bid for each car) for the make and models of vehicles mentioned above super-scribed on the sealed envelope.

It is an item-wise auction and Separate Highest amount H1 will be identified separately for each item through auction (each vehicle) and the vehicle will be awarded accordingly. Hence the amount shall be quoted separately for each vehicle by each individual/bidder(s).

If the H1 bidder did not honor the offer letter of the bank or did not remit the balance amount or refused to pay the balance amount within the stipulated time, Bank reserves the right to forfeit the EMD amount of the H1 bidder.

In such case, Bank may offer the disposal of vehicle to H2 bidder for purchase at H1 rate. If H2 bidder refuses to purchase, the offer will be given to H3 bidder for purchase of vehicle at H1 rate. **Hence, the EMD of H1, H2 & H3 bidder's will be withheld by bank till the H1 bidder remits the balance amount & complete the sale formalities**

Bank reserves the right to cancel or reject any or all offers without assigning any reason.

TERMS AND CONDITIONS FOR SALE OF OLD CAR

The disposal of vehicle shall be strictly on **“AS IS WHERE IS AND WHATEVER THERE IS BASIS”** and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicles can be inspected physically between 12.00 hrs to 16.00 hrs on any working day between 22.07.2026 to 28.07.2026 at Indian Bank, FGM Office, Hazaratganj, Lucknow-226001.

Bidders need to submit earnest money for Rs. 5,000/- per vehicle (Refundable). The earnest money should be payable through **Demand Draft** only in favor of Indian Bank payable at Lucknow, failing which the bidder will not be considered for Tender. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

EMD amount is payable by Demand Draft only in favor of Indian Bank payable at **Lucknow (payment by cash/ cheque/any other mode shall not be accepted)**. Submission of Demand Draft is mandatory

The successful bidder will be required to deposit the total bid amount by means of Demand Draft only in favor of Indian Bank payable at Lucknow within Seven working days after receiving letter from the Bank in this regard.

EMD of the successful bidder(s) will be released only after realization of sale proceeds and transfer of ownership of vehicle. EMD of the bidder will be forfeited who fail to honor the bid amount within the prescribed time limit. No representation in this regard shall be entertained by this department. EMD of successful bidder(s) shall be released only after successful completion of the sale process.

The delivery of the sold vehicle will be arranged only after the successful bidder submits name transferred Registration certificate in original for verification.

The sold vehicle will be shifted by the successful bidder(s) by depositing the money at their own expenses. No assistance/ transportation will be provided by the Bank. Permission to take out the disposed vehicles from Bank's premises will be allowed only on working days (between 12.00 hrs to 16:00 hrs).

Sale letter will be executed in favor of the Successful Bidder on depositing the entire sale consideration. “The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously in the concerned RTO. Bank will not be responsible for any lapse on his part in this regard”.

Delivery of the sold vehicle will be given only after production of Original Registration Certificate for the purpose of verification.

All charges related to sale of car viz. re-registration at RTO, transfer of ownership etc. will be borne by the bidder. Bank will only give its consent wherever required.

Car is being sold on “as is where is and whatever there is basis”. Bidders are advised to ascertain on their own, all information about the nature of this movable property prior to submission of bid. No dispute in this regard will be entertained by the Bank after submission of bids. The Bidder/s will not raise any dispute regarding the terms and conditions of the bid or about the particulars of the vehicle or contest the same, once he has been declared as the successful Bidder/s. Conditional offers/bids shall not be accepted. The rule of caveat emptor is applicable.

The Bidder/s will not be entitled to assign their right to buy the vehicle to any third party or nominate any third party, once they are declared to be the successful Bidder/s. In other words, the Sale will be made only to the successful Bidder/s and not to any third party.

The Successful Bidder shall indemnify and keep at all times indemnified the Bank against any loss or damage that may occur subsequent to the completion of the process of sale

The information in respect of the Bank’s car has been stated to the best of the knowledge from the available records. The Bidders are, therefore, requested to verify the same, in their own individual interests before submitting the bids.

EMD of the individual/firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the Bank shall be final in this regard.

The Bank reserve the right to reject all or any tender in whole or part without assigning any reasons thereof.

EMD of unsuccessful tenders shall be returned within Three/Four weeks of the award of contract to successful party.

The bidder is required to reveal his full name/ name of the authorized signatory of the firm, full postal address, telephone number, mobile number and Email ID.

Disputes, if any, shall be subject to jurisdiction in the Court of Lucknow only.

If the highest quoting individual/firm fail to honor the bid, the contract will be cancelled and its EMD will be forfeited.

Tendering forms should be signed in ink by the authorized signatory only. Photocopy or unsigned or not signed by authorized signatory shall be rejected.

Tendering Individual/firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
