5) Should have carried out similar works of value as below in last 3 years ending on 31.03.2026: • One similar work of value not less than Rs.4.00 Lakhs each (OR) • Two similar works of value not less than Rs.3.00 Lakhs each (OR) • Three similar works of value not less than Rs.2.00 Lakhs each.
