4. Vehicle will not be sold below reserve price.

5. The bidders are advised to quote individually for the make and models of vehicles listed above in the online auction only. No offline bidding will be permitted. Auction will be conducted **online through the Banks approved e-tendering agency** M/s. Antares Systems Limited, Bangalore.

6. Bidders shall register themselves well in advance in www.tenderwizard.com/Indianbank to obtain user ID to participate in the e-auction, any technical queries to usage of the e-auction portal may be clarified from the Bank approved e-tendering agency M/s Antares systems limited ,Bangalore. Last minute calling for registration may be avoided.

7. In case the e-auction date is declared as a holiday or any of the tender opening committee members is not present in the office, the tenders will be opened on the next convenient working day at the same time with proper intimation to qualified bidders.

8. It is an item-wise auction and Separate Highest amount H1 will be identified separately for each item through auction (Each vehicle) and the vehicle will be awarded accordingly. Hence the amount shall be quoted separately for each vehicle by each individual/bidder.

If the second bidder is also not interested, the third highest bidder (H3) may be offered the sale of the car at H1 rate Bank reserves the right to cancel or reject any or all offers without assigning any reason.

Stage 1:

No Manual document / application will be accepted by the Bank.

Stage 2:

Qualified bidder shall participate in the online e-tender for the purchase of old cars which they wish to purchase.

Note: If qualified bidder applied for purchase of 1 No car, then the online portal will display the car of his/her/firm interest. If qualified bidder applied for purchase of 5 cars, then the online portal will display the 5 Nos cars of his/her/firm interest. So they can bid the car of their choice not all.
