  - f. **Experience certificate** - Please note that for the present as well as previous employment, for each position held, please bring specific and explicit experience certificates containing details of full name, full address and telephone numbers and email ID of the employers, period of experience with exact dates, designation held, nature of duties performed, number of persons reporting to you, nature of projects handled, etc.
  - g. Caste Certificate for candidate belonging to SC/ ST/ OBC (Non-Creamy Layer) and EWS category certificate issued by competent authority should be as per the prescribed format notified by Government of India.
  - h. The date of issuance of the OBC (Non-Creamy Layer) certificate should be as 'on or after 1<sup>st</sup> April, 2025' till the date of interview. No request for extension of time for production of OBC (NCL) certificate beyond the said date shall be entertained.
  - i. The EWS candidates are required to produce for verification of 'Income & Asset Certificate' issued based on gross annual income for the Financial Year 2024-25 and valid for the Financial Year 2025-26 as per extant DoPT guidelines, on the date of interview. 'Income & Asset Certificate' must be obtained by the candidates on or before the date of interview.
  - j. Candidates belonging to the Persons with Benchmark Disability (PwBD) category are required to submit a Disability Certificate or Unique Disability Identity Card (UDID) issued in the prescribed format by the competent Medical Authority, and it is clarified that PwBD candidates holding temporary disability certificates categorized as "likely to improve" shall not be eligible for reservation / relaxation benefits under the PwBD category, whereas candidates whose disability conditions are classified as "progressive, non progressive, or not likely to improve" shall be treated as equivalent to permanent disabilities for the purpose of extending such reservation / relaxation benefits.
  - k. An Ex-serviceman candidate has to produce a copy of the discharge Certificate / pension payment order and documentary proof of rank last / presently held (substantive as well as acting) at the time of interview.
  - l. Candidates serving in Government / Quasi Govt. Offices / Public Sector Undertakings (including Nationalized Banks and Financial Institutions) are required to produce a "**No Objection Certificate**" from their employer at the time of interview, in the absence of which their candidature will not be considered and travelling expenses, if any, otherwise admissible, will not be paid.
  - m. Persons eligible for age relaxation must produce certificate issued by the competent authority evidencing their claim of being eligible for the age relaxation
  - n. Any other relevant documents in support of eligibility.
  - o. Candidates will not be allowed to appear for the interview if they fail to produce the relevant eligibility documents as mentioned above.
  - p. Before coming to interview, please ensure that you possess all the credentials as per the eligibility criteria mentioned in the advertisement

2. Please note that you will be permitted to attend the Interview as mentioned above, subject to:
  - a. Your fulfillment of all the eligibility criteria/conditions regarding age, qualification, category, experience etc. (as on 01.09.2025 as stipulated in the advertisement.
  - b. Correctness of information given by you in online application.
  - c. Establishment of your identity.
3. Please note that call letter issued does not constitute an offer of appointment nor does it represent any commitment on part of Organization to select you to any post.
4. The Photograph and Biometrics/IRIS of the candidate will be captured on the date of interview and the same will be verified at any later stage as per the discretion of the Bank. Decision of the IRIS/Biometrics data verification authority with regard to its status (matched or mismatched) shall be final and binding upon the candidates. Refusal to participate in the process of IRIS / Biometric Data capture/verification on any occasion will lead to cancellation of candidature.
5. Candidates are also advised not to change their appearance till the process is completed. Failure to produce the same photograph at various stages of the process or doubt about identity at any stage could lead to disqualification.
6. Please note that, the admission to Interview is provisional only and if it is found at any later stage that you do not conform to the eligibility norms, your candidature will be summarily rejected. Please note that in case at any stage of selection, and even after appointment if it comes to the notice of Bank that you do not/you did not possess the requisite qualification and/or you did not fulfill the eligibility criteria as given in the advertisement, your candidature is liable for rejection.
