In terms Section 3(2D) of the Banking Companies (Acquisition And Transfer Of Undertakings) Act, 1970, no individual or company resident outside India or any company incorporated under any law not in force in India or any branch of such company, whether resident outside India or not, shall at any time hold or acquire by transfer or otherwise shares of the Corresponding New Bank so that such investment in aggregate exceed the percentage, not being more than twenty per cent of the paid-up capital.
