# Rajnath Calls for Naval Co-op for global security

Defence minister Rajnath Singh has called upon the maritime nations to increase their mutual cooperation to meet the global challenges arising out of the current economic situation. Addressing Navy chiefs and heads of delegations from 74 countries during the inaugural ceremony of Exercise MILAN-2026 here on Thursday, Singh said the role of navies in international peacekeeping has increased over time.

There has been an exponential economic growth during the last few decades, leading to massive increases in international trade and transport. Drawing the attention on undersea resources, particularly rare earth minerals, Rajnath said these valuable resources were adding a new dimension to this global tension.

"In addition, there is a need to guard our waters from nefarious terrorist activities, which are spreading tentacles across countries and regions," Rajnath Singh said. He said, underscoring the need for enhanced cooperation among the navies to ensure a safer and more secure future. Pointing out that the

## SIT FINDS DIRECT ROLE OF MLC, HIS WIFE IN MURDER

The Special Investigation Team (SIT) has filed a supplementary charge sheet before the Special SC/ST Court, naming YSRC MLC Anantha Satya Udaya Bhaskara Rao, also known as Anantha Babu, and his wife Lakshmi Durga in the 2022 murder of driver Subramanyam.

Lakshmi Durga has been charged under Sections 302, 301 and 306 read with 114 IPC and relevant provisions of the SC/ST Act. The Special Investigation Team cited CCTV footage, call data records and forensic evidence, including 31 injuries. The MLC is on bail; his wife has sought anticipatory bail.

## NEIGHBOUR SEXUALLY ASSAULTS GIRL

A three-year-old girl was sexually assaulted by a neighbour in the New Port area of Visakhapatnam on Thursday. The accused, Eripilli Yogi alias Gandhi, visited the victim's home to collect ₹300 owed by her father, with whom he played traditional drums at local functions. When her mother went inside to attend to her one

and-a-half-year-old infant, the accused took the three-year-old girl away saying he would buy her chocolates. He took her to a nearby open area and sexually assaulted her. Neighbours who spotted them raised an alarm. He handed the child back to the mother and fled. After seeing the child returned home crying and bleeding, the mother immediately alerted locals and a case was registered at the New Port police station.
